Repair Program

All instruments rented from Murphy's Music Center are eligible for our repair program. For a nominal monthly fee of \$2.00, this offer can protect you from the high cost of repairing damage and wear to your instrument. These terms are subject to the following conditions and supersede all previous versions of this agreement.

1. If the instrument is damaged or deteriorates in performance, we will make the necessary repairs for proper playing condition, free of charge.
2. In the event that repairs take longer than one week, a loaner instrument will be provided free of charge. (subject to availability)
3. Your instrument is protected against fire, theft, or other accidents, occurring not through the fault of the owner. It will be replaced with an instrument of similar brand, age, and condition as determined by Murphy's Music Center. As proof of loss, a police or fire report prepared within 48 hours of the loss must be sent to Murphy's Music Center.
4. Excluded from the program are items that do not affect the performance of the instrument, such as deterioration of finish, scratches, or minor dents. Also excluded are expendable items including, but not limited to, straps, reeds, swabs, lubricants, lyres, drumsticks, drumheads, strings, rosin, and cases.
5. Also excluded is any damage determined by Murphy's Music Center to have been intentionally caused by misuse or abuse.
6. All repairs and replacements must be made by Murphy's Music Center. No other claims will be honored.
7. This agreement is not transferable.
8. This agreement is only in effect for the period of time in which the instrument is being rented.
9. This agreement becomes void when rental payment is not received within 15 days of the due date. It may be reinstated if the account is brought current at the discretion of Murphy's Music Center.
10. You may cancel this agreement any time, however, it may only be initiated at the time of rental.
